Location

Helensburgh is an affluent town set within the Argyll & Bute Council Area and lies approximately 30 miles west from Glasgow. Helensburgh is a popular commuting town to the City with good transport links by both road and rail. The subjects are positioned on West Clyde Street and on the western side of Helensburgh town centre.

The subjects form part of the coastal route, with West Clyde Street being a main arterial road through Helensburgh linking the town with Rhu to the northwest and Cardross and Dumbarton to the East.
