Markinch is both a village and a parish in the heart of Fife, Scotland. Located some 2 miles of Glenrothes and some 20 miles south west from St Andrews. Road communications are via the A911 to the south, giving direct access to the A92 to the west.

Markinch Railway Station is situated 385m from the property and offers regular ScotRail services on the Edinburgh–Aberdeen line with connections to Edinburgh and Fife destinations.

The property is situated on the eastern side of High Street, close to its junction with Brunton Road in a predominantly residential area and occupiers close by include a range of local businesses.

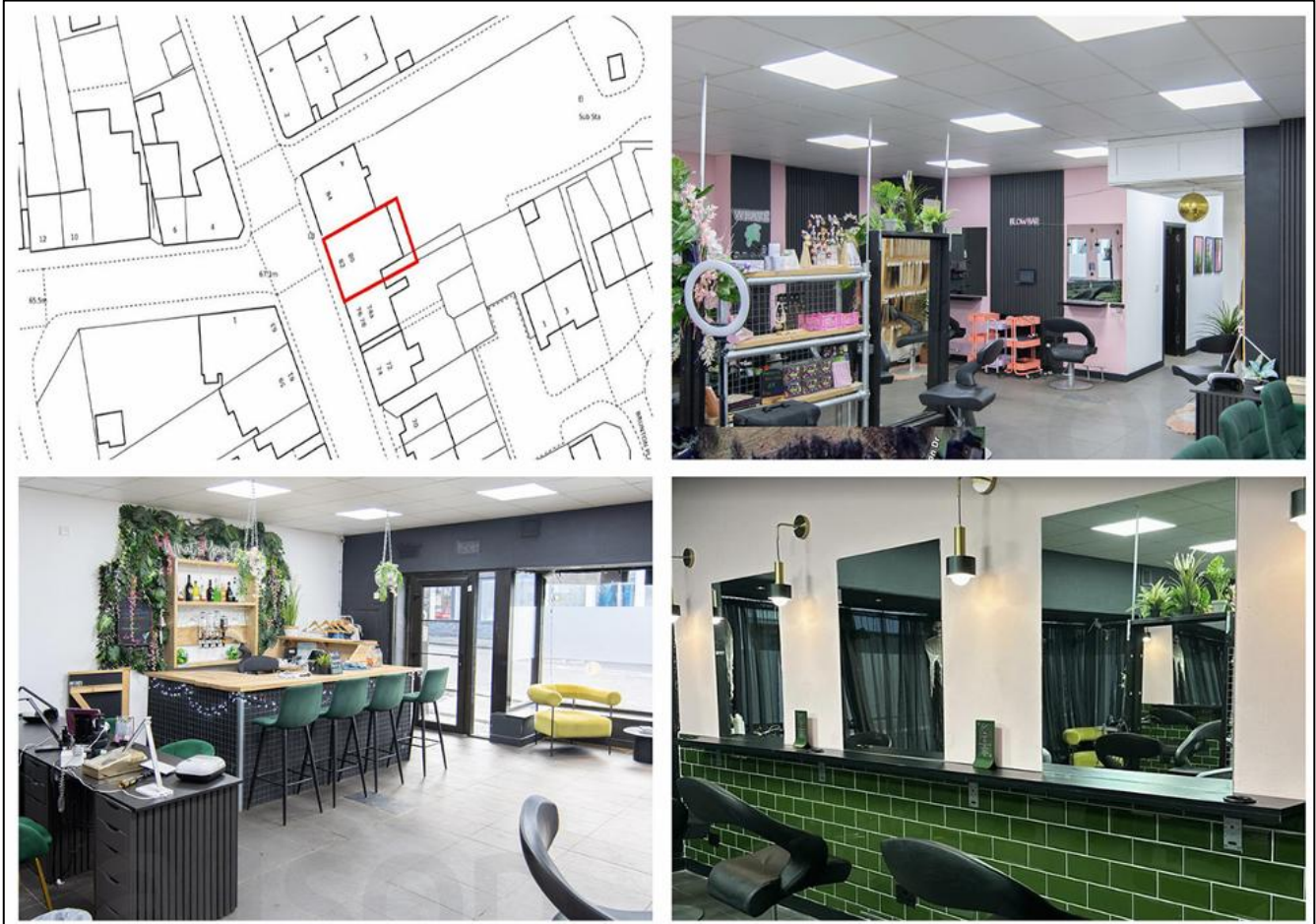
